2. Instructions to bidders

Under this process, the Pre-qualification/ Technical online bid application shall be invited at single stage under two covers i.e. PQ/Technical bid. Eligibility and qualification of the applicant will be first examined based on the details submitted online under PQ or Technical bid with respect to eligibility and qualification criteria prescribed in this Tender document. The Price Bid under the

commercial/financial bid shall be opened for only those Applicants whose PQ/ Technical Applications are responsive to eligibility and qualifications requirements as per Tender document.

- a. The payment for Tender Document Fee and e-Service Fee shall be made by eligible bidders online directly through Debit Cards & Internet Banking Accounts and the payment for EMD can also be made online directly through RTGS/NEFT Please refer to 'Online Payment Guideline' available at the Single e-Procurement portal of GoMP (Govt. of Madhya Pradesh)
- b. Intending bidders will be mandatorily required to online sign-up (create user account) on the website https://mptenders.gov.in to be eligible to participate in the e-Tender. Bidder will be required to make online payment of EMD fee mentioned above in due course of time. If the intended bidder fails to pay EMD fee under the stipulated time frame shall not be allow to submit his / her bids for the respective event / Tenders.
- c. The Bids submitted online should be encrypted and signed electronically with a Digital Certificate to establish the identity of the bidder bidding online. These Digital Certificates are issued by an Approved Certifying Authority, by the Controller of Certifying Authorities, Government of India.
- d. In case of any change in the authorization, it shall be the responsibility of management / partners of the firm to inform the certifying authority about the change and to obtain the digital signatures of the new person / user on behalf of the firm / company. - e. The Applicants/bidders have to complete 'Application / Bid Preparation & Submission' stage on scheduled time as mentioned above. 3. ELIGIBILITY CRITERIA

- 1. The bidder should be an Individual Firm/Partnership Firm/Company incorporated in India and operating for at least last 3 years.
- 2. The Bidder(s) could be individual companies or a Consortium of companies. The Consortium can be of maximum 3 Companies. In case of a Consortium the members must nominate one of them as the Prime Bidder who shall be responsible to JSCL for undertaking and discharging all responsibilities related to the Bid Process and the Project. The arrangement among the members of the Consortium shall be disclosed in the bid and binding on the members and no change in role and responsibility of the members would be accepted after the submission of the bid. The Prime Bidder shall respond to all queries and clarifications and ensure compliance to Bid Process requirements. The consortium partners of any firm should not enter in to consortium / JV / sub contract/ etc. with more than one Prime Bidder. Consortium agreement and power of attorney should be submitted.
- 3. The Bidder or the Prime Bidder Or the consortium partner (in case of consortium / JV) should have completed or currently in operation at least 2 years and should have performed similar nature of work of installation and operations of Mineral Water Dispenser Units for public use and submit documentary evidence in support thereof.
- 4. Copies of registration certificate of the firm/company, Memorandum and Articles of Association in case of firms registered under the Companies Act.
- 5. Experience of installation and maintenance of such Water Dispenser Units in a city. The above experience of bidder should be considered for Govt. / semi govt./PSU only.
- 6. The bidder should have a registered GST number of place where his business is located; Income Tax PAN.
- 7. The bidder who is a defaulter or blacklisted by any government organization before the date of opening of techno commercial Bid cannot participate in the tender.
- 8. The bidder in case of consortium /JV should be in operation of at least 3 years in India, as on 31st march 2019 and having an average turnover of exceeding Rs 75 Cr. in last 3 financial

years. Certified copy from a registered Charted Accountant to establish the general requirements is a must.

9. The letter from the CA certifying that the bidder/consortium/JV in profit in last three year.

4. PROJECT DESCRIPTION & OBJECTIVES

Under the smart city mission for the Jabalpur, the city endeavour to remain a healthy city where the well-being of its citizens is of primary importance. It is in these endeavours, city administration proposes to install "Mineral Water Dispenser Units at various public places in Jabalpur on Built, Own and Operate & Maintain under PPP mode".

Jabalpur Smart city limited create an infrastructure for providing 24 x 7 potable water vending facility to general public at approachable distance.

SCOPE OF WORK

- a. This project is to provide regular, potable mineral and cold water to the general public at large at various markets and other public places.
- b. Bidder will install Operation and Maintenance of Water dispenser units as per specifications, listed out in **Annexure "A"** hereto.
- c. No payment towards cost of Installation or O & M shall be paid by JSCL along with the advertisement rights.
- d. Electricity / Water connection will be provided by JSCL. However cost of Water and Electricity charges will also borne by the Successful bidder as per the rules and regulation & rates of JMC/ MPPKVVCL.
- e. Mineral water dispenser unit should be placed correctly and no obstacle in the bidder shall repair, maintain and operate the allotted Water dispenser unit with structure and electrical fittings and fixtures, in good condition, during the concession period. However for the non-maintenance of water dispenser units by the Successful bidder may result into termination of the contract.
- f. Bidder will not charge any cost from consumer's for the treated water during the contract

period.

- g. Treated Water quality should be according to norms of **WHO drinking water standards/**Indian standard with up to date amendments
- Mineral water dispenser unit should be placed correctly and no obstacle in traffic will be accepted.

WATER QUALITY

- a. The Mineral water dispenser unit shall dispense potable water system operated vide minimum 5 stage cleaning system (including Reverse osmosis membrane and UV filter compulsory). The dispenser shall have a real time water quality showing monitor. The company has to get certified the system 3rd party certified every year.
- b. The Mineral water dispenser unit shall be equipped with real sensing technology connected via a central server. Drinking Water quality must be ensured as per the WHO drinking water standards/ Indian standard with up to date amendments.
- c. To upkeep and maintain the cleanliness, it will be allowed to use anti-skid mat in the front/surrounding of unit.
- d. To minimize the wastage of water through RO system.
- Submission of monthly report: a monthly report of each Water dispenser unit shall be submitted to JSCL/JMC with each and every details pertaining to operation of water dispenser unit
- f. Any consequences by supplying poor quality of water will totally responsibility of successful bidder.
- g. Water work department chemist of Jabalpur Municipal Corporation will certify the quality of water time to time as required by JSCL/JMC.


5. COMPLETION PERIOD

a. The date of commissioning of Water dispenser units will be reckoned from date of physical installation of Water dispenser units after certifying from project officer.

b. The locations will be identified by project officer and consented by successful bidder. The total time limit for this work will be 10 years. The date of commencement of work will be reckoned after successful installation of first Water dispenser unit.

6. UNIT AND ADVERTISING DISPLAY AREA

- a. 200 Sq. Ft. areas for the Water dispenser unit including all components.
- b. 200 Sq. Ft. areas per site, for the usage of commercial Space for advertising are permitted.
- c. Any kind of violation in MP Outdoor media policy 2017 will be penalized heavily as deemed fit to Executive Director.



7. LOCATIONS

The Mineral Water dispenser units may be installed at Bus Stops, public places under JMC limit, Parks, Parks, entrance/ exit of Bus Stations, parking areas any other place identified by the Municipal Corporation, There shall be minimum distance of 300 metres between 2 units. The site shall not interfere with pedestrian movement and therefore the units shall be installed within the ROW (as per the provisions of the MP outdoor media police 2017), with any existing structure like public utility kiosk, bus stop, etc.

The Identified locations of Water dispenser units should be strictly adhering as per MP outdoor media police 2017.

- a. The locations mentioned above are preliminary identified. But it can be changed as per their feasibility with prior approval of project office.
- b. The successful bidder should obtain and coordinate to concern govt./public/private authority for seeking necessary approval as required.
- c. Water dispenser unit installation other than approved location liable for penalty as recommended by Executive director/CEO JSCL.

8. DISPLAY OF ADVERTISEMENT

a. The bidder shall have the right to display advertisement at the Mineral Water dispenser unit during the contract period. The advertisement area is to be created on / above the front only on two sides of the structures, restricted as Annexure "B". The advertisement shall be concealed within the land allotted only. The displays at the Water Dispenser Unit

- to be constructed shall be per the design with mutual understanding between the Successful bidder and JSCL. The decision of Supreme Court, High Court, State and local authorities should be adhered.
- The bidder shall not exceed the prescribed portion of the Mineral Water dispenser unit for display of advertisement and shall ensure that no colour matching that of the traffic signals i.e. Red, Orange and Green is used for display of advertisement.
- c. The bidder shall not display any advertisement related to liquor, cigarette, tobacco or tobacco products or any advertisement which is abusive/obscene/vulgar/negative, in nature, or which violates the code of conduct, in any manner whatsoever, and ensure that public decency is maintained. He shall also not allow display of any religious advertisement that may cause any resentment among the public, in any way whatsoever.
- d. The advertisement shall not contain any thing that contravene the Advertising Industry's Code of Ethics, (refer List of Negative Advertisements) or that otherwise causes a traffic hazard.
- e. List of negative advertisements (As contained in the Outdoor Advertising Policy of govt. of India/ MP and JMC/JSCL):

- During the period of contract, if on any grounds any advertisement(s) is/are objected to by any competent authority then the Executive Director/CEO, Jabalpur Smart City Limited or his authorised representative shall have the right to remove such advertisement(s) at the cost of Successful bidder and the JSCL shall not be liable to pay any refund/damage or claim thereon. The Successful bidder, will however, be permitted to display any other advertisement in lieu thereof. No claim for damages etc. will be maintainable on that account.
- After installation of the water dispenser unit, the JSCL will allow complete discretion to the Successful bidder to exercise advertisement rights and use the space available for commercial purposes, provided it does hinder smooth operation and usage of the water dispenser unit.

8. YEARLY FEE (YEAR MEANS FINANCIAL YEARS)

- Successful bidder will pay monthly fees as per their allotted site in first week on every month to JSCL.
- The successful bidder should pay monthly fees as per prescribed manner and time. The delay in payment will be charge at interest of 18% per annum.

9. TERMINATION OF CONTRACT

• The JSCL reserves the right to terminate the contract for breach of any of the terms and conditions of allotment, after providing due opportunity of hearing to the bidder.

10. Penalty in case of Non-performance

- a) The successful bidder will ensure the quality of drinking water as per WHO drinking water standards Edition-IV (2011)/ Indian standard and submit chemical analysis report time to time as directed by project officer.
- b) The non performance/non functional of Mineral Water dispenser unit for more than 4 hours in a day during operational hours will be considered as 1 day of non operation. Not dispensing of water shall be termed as non performance/non functional.
- c) In case the water quality is not as per standard the Water dispenser unit should stop dispensing water immediately. It the machine is found dispensing water not confirming to standard JSCL/JMC shall impose a penalty of Rs. 2,000/- for each such event for each Water dispenser unit.
- d) In case of non operation/non functional of Water ATM beyond 4 hours in a day, penalty shall be imposed as follows:

a. Up to 2 Days - Rs.500/-per day/per unit

b. From 3- 5 days - Rs.1000/- per day/per unit

c. Above 5 days - Rs.1500/- per day/per unit

- e) These penalties will be decided by the competent authority by reviewing the data obtain from ICCC on sensor based monitoring system. The maximum penalty should not be more than per month Rs. 10000/-.
- f) Beyond the above mentioned days of non performance/non functional of any water unit JSCL may initiate the termination of the License Agreement with forfeiture of Security Deposit after adjustment of any dues payable to JSCL.
- g) If Total penalty imposed is more than Rs. 1,00,000 during the agreement ,the agreement may be terminated with forfeited of Security Deposit (FDR), subject to approval of Executive Director, JSCL.

h) The JSCL vide the contract agreement shall reserve right to terminate the contract agreement, if the company violates any of above said regulations and following conditions:
a. The company continues flouting of provisions of the Madhya Pradesh Outdoor media police 2017 and its amendment.

11. DAMAGES

 Any damage to the foot-paths, tiles, kerb-stones, central verge or any other ancillary structures, during construction / maintenance / operation of the Water dispenser unit, including supporting structure shall be the sole responsibility of the Successful bidder, which shall be made good by the Successful bidder, as per existing specifications, at its own cost.

12. COMPLIANCE OF SPECIFICATIONS

• The specification of the ATM is strictly adheres as mentioned in bid document.

13. GST

 GST shall be exclusive of the rate quoted and as applicable with up to date prescribed by the government.

14. TITLE OF LAND

 JSCL shall continue to be the absolute owner of the land. JSCL will allow the bidder to install, operate, maintain and advertise on the land where the mineral water dispenser unit is installed.

15. DESIGN CRITERIA FOR VARIOUS ELEMENTS OF PROJECT

• The bidder will be responsible to carry out the necessary surveys and obtain the required statistical data/information for the sake of actual planning and execution of the machine that would form a part of the project. It would be binding on the part of the Successful bidder to

have designs that would have an ethical look and contribute to the enhancement of the beauty of its precincts. Wherever applicable
