1. BIDDING TERMS

- A. Jabalpur Smart City Limited (JSCL) (the "Authority") is the nodal agency for the implementation of the Smart City Mission in Jabalpur. JSCL invite a "Expression of Interest" for the operation and maintenance of Sports centers at Shiv nagar & shakti nagar, Jabalpur, M.P., India. The EOI document & other details can be downloaded from the website: www.jscljabalpur.org and www.smartnet.niua.org.
- B. The Project will be Operate and maintained by the selected bidder (The "concessionaire"). The Project implementation period shall be 3 (Three) months and operate and Maintain for a period of 10 Years (the "concession period") after completion of implementation/installation. The period of O&M can be renewed for another 10 years by the authority depending upon the performance of concessionaire.
- C. The Concessionaire need to give a detailed technical presentation to JSCL covering the following.
 - a. Details on technical solution envisaged in the project,
 - b. Indicative approach to be adopted.
 - c. Suggest with proper justification, the various revenue modes which can be part of the FOI
- D. JSCL will receive EOIs from applicants, who will further participate in technical discussions with JSCL, demonstrate their solutions / capabilities / functionalities / features through detailed presentations. This presentation should provide a representative solution to integrate various features / aspects / functionalities / applications of the project as per the objective(s).
- E. The applicants shall also provide their inputs for identification and quantification of revenue streams, making their own assessments of revenue potential. Details, as necessary, may be shared with JSCL.

2. Purpose of This EOI

The Sports center at Shiv Nagar & Shakti Nagar is to encourage the young and talented sportspersons of the city and to provide modern and international level sports facilities.

This project includes basketball ball, volleyball, jogging track, swimming pool, children's playground, development of green areas etc. the project also includes Indoor facilities of badminton court, place of gymnasium, administrative rooms, open gym and public utilities. The building is constructed using pre-fabrication technology.

To sustain the development and provide the developed facilities Jabalpur Smart City Limited are willing to appoint an eligible, qualified & capable agency for operation and maintenance of Sports center at shiv nagar & Shakti Nagar. The concessionaire will install the required equipment of sports like basketball, Swimming pool, volleyball, Gymnasium machines, and operate & maintain the sports center for next 10 years and pay the annual premium to Jabalpur Smart City Ltd.

Jabalpur Smart City ltd may invite the concessionaires for a meeting/presentation after the submission of this EOI. the appropriate received suggestions will be incorporated in the further bidding process to select the concessionaire.

3. Responsibilities of JSCL

- A. JSCL will Complete the Development of Sports center at Shiv Nagar & Shakti Nagar and handover the premises to the Concessionaire.
- B. All the developed and installed assets will be handover with the site to the concessionaire and further the O&M of all the assets is the responsibility of concessionaire.
- C. JSCL will provide the water supply for irrigation purpose. Further the O&M will be the responsibility of the concessionaire.
- D. The indoor and outdoor lighting fixture will be provided by JSCL. The electricity supply for the same will be provided by JSCL. Further the Operation & Maintenance will be the responsibility of the concessionaire. The payment of electricity bill will be the responsibility of the concessionaire.

4. Scope of Work & Terms of Reference

- A. The scope of work will broadly include Sports center at Shiv Nagar & Shakti Nagar and operation and maintenance thereof till the period of 10 (ten) years in accordance with the terms and conditions. The Concessionaire can collect appropriate user charges from the users.
- B. The concessionaire will be responsible to run the assets operations at the site with their own qualified employees.
- C. The concessionaire shall run the basketball facilities, volleyball facilities, Swimming pool, gymnasium, Badminton facilities, and other related activities.
- D. All the necessary equipment shall be installed and maintained by the selected concessionaire in excellent running condition throughout the contract period of 10 years.
- E. The concessionaire can charge the user fees for basketball, volleyball, swimming pool, gymnasium, Badminton & other sports events.
- F. The concessionaire will depute the coaches for different sports along the trainers for gymnasium.
- G. The concessionaire can conduct the competitions, Sports events, state and national championships in the premises.
- H. This concessionaire can earn the revenue by collecting user charges and conducting sports events.
- I. The essentials requirements like Dust bins, drinking water facilities, etc. will be established by Concessionaire.
- J. During the operations, the assets are the responsibility of the concessionaire and in case of any maintenance in plumbing, electrical work, will be the responsibility of the concessionaire.
- K. The concessionaire will seek the permission of the authority before any maintenance/alteration/addition.
- L. No sub-agency/ sub-leasing / sub-renting will be allowed under any circumstances whatsoever.
- M. All the operational expenditure and tax compliances will be the responsibility of concessionaire like electricity bill, water Charges, solid waste Charges, etc.
- N. The assets shall be transferred to the authority post the concession period in well maintained and running condition.
- O. The entire premises will be taken care, maintained, and operated by the concessionaire.

P. Term and conditions regarding security deposit etc will be publish in the RFP document.

5. Qualification Criteria for Concessionaires:

- A. The Agency/Firm should have an experience of at least 03 (three) years of running sports academy/sports center/sports coaching/gymnasium etc.
- B. The firm should have requisite establishment registration Certificate for doing the existing activities.
- C. The Concessionaire will be selected through open competitive bidding process and would be required to carry out the following activities or as mentioned in the document but not limited to same.
 - I. Site investigation and inception
 - II. Prepare detailed techno-commercial plan for the operations and complete necessary compliances to undertake approval from necessary authority(s)/departments.
- D. The Applicant has to submit the general information about the individual firm/ partnership firm along with the Expression of Interest.
- E. The Expression of Interest must be delivered at the following address on or before 1730 hours local time on 25.09.2021. Applications received after the prescribed date will not be considered.

6. How to Apply:

- A. Interested Legal Entities may submit Expression of Interest with all the necessary documents as prescribed herein in a sealed envelope written the name of project and easily identifiable name and address of the submitting company along with the covering letter duly signed by an authorized signatory by submission date.
- B. The concessionaires are requested to also share the experience and suggestions for operations of such project. the appropriate suggestions will be incorporated in the further bidding process.
- C. It is also requested to suggest the financial modelling and feasible options to operate such project.

- D. The Bids will be invited for the Project on the basis of the highest annual premium to be quoted in the Financial Bid (the "Upfront Premium").
- E. The highest annual Premium shall constitute the sole criteria for evaluation of Bids.
