1. BIDDING TERMS

- A. Jabalpur Smart City Limited (JSCL) (the "Authority") is the nodal agency for the implementation of the Smart City Mission in Jabalpur. JSCL invite a "Expression of Interest" for Operation and maintenance of Non-Motorized Transit corridor at Wright town, Jabalpur, M.P., India. The EOI document & other details can be downloaded from the website: www.jscljabalpur.org and www.smartnet.niua.org.
- B. The Project will be implemented, Operate and maintained by the selected bidder (The "concessionaire"). The Project implementation period shall be 3 (Three) months and operate and Maintain for a period of 10 Years (the "concession period") after completion of implementation/installation. The period of O&M can be renewed for another 10 years by the authority depending upon the performance of concessionaire.

2. Purpose of this EOI

NMT corridor (above Omti nala) is developed under Jabalpur Smart City mission. Most of the major storm water drains of Jabalpur are covered by RCC BOX culverts under JNNURM Projects. Omti Nala is one of the major drains crossing the ABD Area of Jabalpur Smart City is also covered by RCC Box Culvert. The project was envisaged to provide an alternative walking way a within the city, but after the development the project has become a major recreational zone and now people are using this place as entertainment zone, recreation zone, morning-evening walk place, sports activities and family gathering space.

This stretch of 1.2 KM long from Bhatkhande Sangeet Vidyalaya (Madan Mahal) to old bus stand (In front of Nav Bharat press) is having major residential development of Wright town area and the education institutes like MLB school and home science college. The stretch is all over surrounded by good commercial and residential activities.

JSCL wants to explore this opportunity and open few commercial outlets to earn the revenue. The permissible activities of these areas could be.

- 1. Food Kiosks.
- 2. Entertainment sports
- 3. Children games, and other related activities
- 4. The revenue can be earned from Advertisement also.

To sustain the development and identity Jabalpur Smart City Limited are willing to appoint an eligible, qualified & capable agency for operation and maintenance of NMT corridor as Recreational zone. The concessionaire will develop operate and maintain the recreational zone for next 10 years and also pay the annual premium to Jabalpur Smart City.

Jabalpur Smart City Itd may invite the bidders for a meeting/presentation after the submission of this EOI. the appropriate received suggestions will be incorporated in the further bidding process to select the concessionaire.

3. Responsibilities of JSCL

A. JSCL will Complete the Development of NMT corridor and handover the premises to the Concessionaire.

- B. ALL the developed and installed assets will be handover with the site to the concessionaire and further the O&M of all the assets is the responsibility of concessionaire.
- C. The landscape work will be done by JSCL along the NMT corridor. further the O&M will the responsibility of concessionaire.
- D. JSCL will provide the water supply for irrigation purpose. further the O&M will the responsibility of concessionaire.
- A. The street lighting fixture will be provided by JSCL. The electricity supply for the same will be provided by JSCL. Further the Operation & Maintenance will be the responsibility of the concessionaire. The payment of electricity bill will be the responsibility of the concessionaire.

4. Scope of Work & Terms of Reference

- B. The development work of NMT is under process. The proposed recreational zone will be operational under the project only.
- C. The scope of work will broadly include Operation, and maintenance of recreational zone, at NMT corridor, with a minimum investment, not less than 40-50 lakhs, and operation and maintenance thereof till the period of 10 (ten) years in accordance with the terms and conditions. The Bidder can collect appropriate user charges from the users.
- **D.** The concessionaire can set up the food zone, food kiosks, Adventure zone, Entertainment sports, Children games, and other related activities permitted by the authority. **All the installations and setup shall be outside the box drain surface.**
- E. The concessionaire can also earn revenue from advertisement also.
- F. There will be no entry fee for the usage of premises for activities like walking, jogging, picnic, cycling, physical exercise etc.
- G. All the design of food zone, kiosks, etc and its locations will be approved by the authority before the installation/execution.
- H. This agency can further rent out the kiosk to other people for defined activities like stationery shop, book stall, food kiosk, gift shop, souvenir shop, Juice corner and other define permissible activities.
- I. The size of the kiosks/shops cannot be more than 10x12 feet each. (Reference image attached in Annexure -A)
- J. The maximum number of shops for the stretch of 1.2 km will be 50.
- K. Any activities which are restricted in the residential areas are not allowed.
- L. The manufacturing & Industrial activities are not allowed.
- M. The essentials requirements like public utilities, Dust bins, drinking water facilities, etc will be established by Concessionaire.
- N. Further during the operations, the assets are the responsibility of the concessionaire and in case of any permanent maintenance in plumbing, electrical work, will be the responsibility of the concessionaire.
- O. The concessionaire will inform the authority before any permanent maintenance.
- P. All the operational expenditure and tax compliances will be the responsibility of concessionaire like electricity bill, water Charge, solid waste charge, etc.
- Q. The assets will be transferred to the authority after the concession period.

- R. All the design elements need to be procured by the concessionaire as per the approval of the authority.
- S. The entire premises will be taken care of, maintained, and operated by the bidder.

5. Qualification Criteria for Bidders:

- A. The Agency/Firm should have an experience of at least 03 (three) years of running a Commercial shops/kiosks/Eatery/Hotel etc.
- B. The firm should have requisite shop and establishment registration Certificate for doing the existing business.
- C. A Valid Food License issued by the Competent Authority of the State in the name of the firm/shop.
- D. The Agency/Firm Should possess requirement such as GST registration, PAN Card, Gumasta registration etc.
- E. The Concessionaire will be selected through open competitive bidding process and would be required to carry out the following activities or as mentioned in the document but not limited to same.
 - I. Site investigation and inception
 - II. Prepare detailed commercial plan for the operations and complete necessary compliances to undertake approval from necessary authority(s)/departments.
- F. The Applicant has to submit the general information about the individual firm/ partnership firm along with the Expression of Interest.
- G. The Expression of Interest must be delivered at the following address on or before 1730 hours local time on 25.09.2021. Applications received after the prescribed date will not be considered.

6. How to Apply:

- A. Interested Legal Entities may submit Expression of Interest with all the necessary documents as prescribed herein in a sealed envelope written the name of project and easily identifiable name and address of the submitting company along with the covering letter duly signed by an authorized signatory by submission date.
- B. The bidders are requested to also share the experience and suggestions for operations of such project. the appropriate suggestions will be incorporated in the further bidding process.
- C. It is also requested to suggest the financial modelling and feasible options to operate such project.

- D. The Bids will be invited for the Project on the basis of the highest annual premium to be quoted in the Financial Bid (the "Upfront Premium").
- E. The highest annual Premium shall constitute the sole criteria for evaluation of Bids.
