# **NOTICE INVITING**

# Expression of Interest (EOI) for Design, Supply, Installation, testing and commissioning of passenger rope way system at Madan Mahal, Jabalpur

1. Jabalpur Smart City Limited (JSCL) is the nodal agency for the implementation of the Smart City Mission in Jabalpur. JSCL invites Expression of Interest from experienced firms /Joint Ventures/Association for short listing of bidders for Design, Supply, Installation, testing and commissioning of passenger rope way system at Madan Mahal, Jabalpur, as part of the Smart City Project. Interested firms /Joint Ventures/Association are requested to submit their expression of interest for the above work. #### 2. The Scope of Work consists of:

- a) To carry out detailed design for Ropeway with decorative lighting with approx. 3 km length and 4 stations in between the rope way.
- b) The rope way will work as hop on hop off concept.
- c) The bidder will carry out the study to prepare the techno economic feasibility report and as per the report the details of components, Number of towers, Tower Height, Distance between towers, Interval between cabins, Line speed, Distance between cabins, Number of Cabins, Cabin Capacity, Trip time etc. will be decided.
- d) The rope way is to be constructed over madan mahal hills catering all the major destinations like Bajna math, Pisanhari madiya, Osho ashram and Madan mahal fort. The bidder is advised to visit the site and contact JSCL for more information if required.
- e) All the clearances i,e. environment, forest, wildlife will be taken by Jabalpur smart city Ltd. with the help of the bidder. The reports, documents and details etc. required for clearance and approval purpose will be prepared and submit to the concerned authority by the bidder.
- f) Development of Terminal station at Bajna math, Pisanhari madiya, Osho ashram and Madan mahal fort locations along with all other necessary infrastructure facilities.
- g) Any other works, which are required for the successful completion and commissioning of the Project as per the prevailing laws and rules applicable at that time may be considered.
- 3. The project will be implemented Design, Supply, Installation, testing and commissioning basis i.e., bidder will design, construct and also maintain for period of 5 years after completion of work. The time period for completion of the project shall be 24 months from the award of the project.
- 4. The successful bidder would be required to carry out the following activities or as mentioned in the RFP but not limited to these,
  - a) Site investigation including topographical and sub-soil investigation.
  - b) Design & survey with detailed drawings.

- c) Prepare detailed design and drawings for ropeway and approaches (if required) duly proof checked by IITs, NITs or Engineers India Limited (EIL).
- d) The complete design and drawings which has been proof checked shall be submitted for approval from the Employer before taking up the execution.
- e) Techno Feasibility Study facilitate Reconnaissance Survey for selection of the best technically suitable alignment (i.e. examination, exploration, inspection, investigation, observation.
- f) This includes survey details along the selected alignment with elevation details and survey charts.
- g) Finalization of the best Suited Ropeway System for the site.
- h) The complete design and drawings which has been proof checked shall be submitted for approval from the Employer before taking up the execution.
- i) Carry out construction of rope way as per approved drawings.
- j) Maintain the ropeway and its approaches for a period of 5 years after its completion.
- k) JSCL will engage an Engineer to supervise and approve the works during the period of execution.

#### **Qualification Criteria for Bidders:**

- a) The Applicant or its Partner/Associate in case of JV/ Association firms must have designed and executed rope way system during the last 10 years. The bidders must submit detailed particulars and GADs (i.e., name of Client, location of the ropeway, year of award and completion, value of project, details of technology, type of ropeway etc.) of such projects executed by them.
- b) The Firms should have experience of execution of at least 2 Nos Mono Cable / Bi Cable passengers/material Ariel Ropeway of capacity not less than 400 PPH/TPH, with the length of ropeway more than 500mtrs.
- c) The applicant can be a single firm or voluntarily formed joint venture meeting the eligibility criteria as above.
- d) Should have executed / under execution/ awarded projects anywhere in India on PPP mode, have experience in Construction, and Operation & Maintenance of Commercially viable Projects.
- e) Should submit copy of Purchase Order or Performance Certificate /Successful commissioning & Operation /Acceptance certificate issued by the client in last 10 years.
- f) Should not have been blacklisted/debarred by any Govt./ Semi Govt./PSU
- g) organization in India or abroad

  The Applicant has to submit the general information about the individual firm/each partner of
  Joint Venture in the prescribed formats (Annexure I, II and III available) along with the Expression
  of Interest.
- h) The Expression of Interest must be delivered at the following address on or before 1730 hours local time on 21.12.2017. Applications received after the prescribed date will not be considered for shortlisting.
